Consumer Fact Sheet: The Joint Processing of SSI and Food Stamps in Illinois

Background

The **Food Stamp Program (FSP)** is a program that provides monthly benefits to help low-income households buy food. **Supplemental Security Income (SSI)** is a cash benefit designed to help aged, blind, and disabled people, who have little or no income, meet basic needs for food, clothing, and shelter. If you are eligible for SSI then you are automatically eligible for Food Stamps. In fact, when you go to the Social Security Administration (SSA) office to apply for SSI, you may be able to apply for Food Stamps at the same time. This fact sheet describes some important information for you to know about Food Stamps when you go to an SSA office and you are applying for SSI or you already receive SSI.

Who Can Apply for Food Stamps at a local SSA Office?

You can apply for Food Stamps at an SSA office if you live in a "pure SSI household". That means, if you and everyone in your household are applying for or are already receiving SSI payments, any SSA office will help you complete the food stamp application and send it to the Illinois Department of Human Services (DHS) for you. If you live in a pure SSI household, you do NOT need to go to DHS for an inperson interview.

Can I Apply for Medicaid and TANF at the local SSA office, too?

No. If you think you may be eligible for Medicaid or TANF, you need to go to your local DHS office to apply for these benefits. Call the DHS Help Line at 1-800-843-6154 or 1-800-447-6404 (TTY) to find out where the nearest office is to you. <u>Can I Apply for Food Stamps at an SSA Office when I Go There for a Redetermination of my SSI Benefit?</u>

Yes. If you live in a pure SSI household, you can apply for Food Stamps at an SSA office at any time.

What are the Income and Asset Guidelines for SSI Applicants Applying for Food Stamps?

Generally, you are eligible for SSI if you have earned income of \$900 (or less) a month or \$1500 (or less) a month if you are blind. If you qualify for SSI, then you qualify for Food Stamps. The assets of people who receive SSI are NOT counted in determining Food Stamp benefits.

Where Can I Go to Apply for SSI and Food Stamps?

You can also check the online "Social Security Office Locator" (https://s044a90.ssa.gov/apps6z/FOLO/fo001.jsp) to look up offices by zip code.

What do I Need To Bring to SSA in order to Apply for SSI and Food Stamps?

When you go to apply for SSI and Food Stamps at the SSA office, you should have with you:

How Much will I Receive in Food Stamps Each Month?

The amount of food stamp benefits depends on family size, income and certain expenses (such as out of pocket medical expenses). The minimum benefit amount is \$10/month. In 2006, the average monthly benefit was about \$113 per person and about \$238 per household. Households with a disabled person receive, on average, about \$107 per month.

How are Food Stamp Benefits Provided?

Benefits are provided through the Illinois Link System, an electronic system that allows someone to use a plastic card, similar to a bank card, at grocery store terminals. A person uses the card to authorize transfers from their benefit account to a retailer account to pay for products received. You need to remember your password in order to use the card.

What if I Need Food Stamp Benefits Immediately?

You may be able to receive emergency or "expedited" benefits if:

Your monthly income, cash and bank accounts are less than your rent or mortgage plus your
utility costs; OR your monthly income is less than \$150.00 and your cash and bank accounts are
not more than \$100.00; OR at least one person in your household is a migrant farm worker and
your cash and bank accounts are not more than \$100.00.

If you meet any of these requirements, SSA will mark your application for expedited Food Stamps. Once DHS receives the application, your benefits should be available within five days.

What is the Timeline for Receiving Regular (non-Emergency) Food Stamp Benefits?

You should receive a written decision about your Food Stamp benefits within 30 days of your application at SSA. Make sure you receive a receipt from SSA that shows the date in which you applied for Food Stamps.

What is the Appeals Process if I Do Not Get Food Stamps after Applying at SSA?

If you do not agree with the Food Stamp decision or benefit amount, you should make an appeal right away. Contact the DHS Bureau of Assistance Hearings at 1-800-435-0774 to file an appeal.

How Do I Recertify For Food Stamps?

You must notify DHS if your address has changed so that they can find you when it is time to recertify. Information about recertification will be provided to you with your initial benefit and when it is time to reapply.
