#11-030-9007 The complaint alleges that a recipient was placed in seclusion, restrained, and administered psychotropic medication for no adequate reason. Also, it is alleged that the recipient's physician used profanities while in individual counseling. A motion was made to accept the complaint for investigation. It was properly seconded and passed.

#11-030-9008 The complaint alleges that a recipient was admitted into treatment, given forced psychotropic medication, and prevented from signing himself out, all in violation of the Mental

Health Code. A motion was made to accept the complaint for investigation. It was properly seconded and passed.

#11-030-9009 The complaint alleges that the hospital refused to acknowledge a recipient's guardian and thus her ward was held for 6 days and his medication altered without the guardian's input. A motion was made to accept the complaint for investigation. It was properly seconded and carried.

#11-030-9010 The complaint alleges that a recipient was restrained and administered psychotropic medication in violation of the Mental Health Code. A motion was made to accept the complaint for investigation. It was properly seconded and passed.

Pat made a motion to go into closed session at 5:47 p.m. pursuant to Section 3955/21 of the Guardianship and Advocacy Act to discuss reports and other matters which could not be discussed without revealing confidential information. The motion was properly seconded and carried.

The HRA returned to open session at 5:55 p.m. having taken no action in closed session. A summary of the closed session included progress reports on open cases and response discussion and case closure for case #10-030-9003 Kindred, #10-030-9009 Kindred, #10-030-9010 Read, and #10-030-9017 Chicago lakeshore.
