The regular scheduled meeting of the Human Rights Authority, South Suburban Region was called to order by Judith Rauls, Chairperson at 9:05 a.m.

I. CALL TO ORDER

The Chairperson read the confidentiality statement. It was determined that a quorum was present, and all business could be conducted.

II. COMMUNICATION

It was moved by Bruce Berry to accept the November 18th, 2010 Meeting Minutes without changes. Motion was seconded by Michele Arthur and carried.

III. NEW COMPLAINTS

There was one new complaint for discussion.

11-040-9009 (Nursing Home) Bruce Berry moved to not accept the complaint about discharge because the guardian is satisfied with the current placement. The complaint about the resident being abused by the staff and peers was referred to the Illinois Department of Public Health for possible investigation. The Regional Ombudsman Office has been contacted concerning the complaint about elderly abuse when the resident lived with a family member. Motion was seconded by Kimberlee Brewerton and carried.

Ratify Acceptance of New Complaint

11-040-9008 (New Hope Center) The case was not ratified because Kimberlee Brewerton could not participate in the voting process.

VI. Accept Response/ Closures/ Make Report Available to the Public

10-040-9001 (Imperial Nursing Home) Kimberlee Brewerton moved to keep case opened for documentation such as the target date for reviewing residents' chart to ensure that they are seen by a physician as required by law. The HRA is also requesting documentation that physicians have been informed that residents must be seen as directed by statutes. Michele Arthur seconded and motion carried.

10-040-9005 (Heather Health Care) Bruce Berry moved to keep the case open for staff training documentation. And, written evidence that residents were informed that the facility's Visiting Policy does not restrict them from leaving the unit. Carol Genutis seconded and motion carried.

10-040-9010 (Palos Community Hospital) Michele Arthur moved to keep the case open for a response to the report that contains violations. The report cover letter is dated November 22nd, 2010. The provider is still within the 30-day timeframe allowed to respond to the report of findings. The case will be reviewed at the next meeting. Carol Genutis seconded and motion carried.
