

Egyptian Regional Human Rights Authority
Meeting Minutes
May 26, 2011

I: Call to Order:

The regular monthly meeting of the Egyptian Regional Human Rights Authority was called to Order at 6 PM by Brad Friend, in the absence of the Chairperson and Vice-Chairperson. The meeting was held the Illinois Guardianship and Advocacy Commission Office, 7 Cottage Drive in Anna.

III: Determination of a Quorum: It was determined that a quorum was present.

IV: Introductions by the Chairperson: None

V: Review and Approval of Minutes: Mumford moved to accept the minutes of the 03/29/11 HRA Meeting as written. The motion was properly seconded (Farmer) and carried.

VI: Confidentiality Statement: Acting Chairperson Friend waved the reading of the Confidentiality Statement since no members of the public were present.

VIII: New Business:

A: New Complaints

11-110-9040...A community mental health provider has refused to provide services for a disabled individual. The 15-year-old female as a diagnosis of Asperger Syndrome...High Functioning Autism... It is reported that the she is having severe behavior problems, which would benefit from behavioral intervention therapy; however, the provider has refused to provide the programming. Mumford moved to accept the new complaint for investigation. The motion was properly seconded (Livesay) and carried.

11-110-9041..A recipient at a state-operated mental health facility was inappropriately placed in restraints. It is reported that the recipient was not aggressive toward self or others prior to the application. Rambeau moved to accept the new complaint for investigation. The motion was properly seconded (Livesay) and carried.

11-110-9042...It is alleged that a recipient at a state-operated mental health facility is not receiving services in the least restrictive environment. The recipient has a legal status of UST (Unfit to Stand Trial). Mumford moved to not accept the new complaint for investigation. The motion was properly seconded (Friend) and carried.

11-110-9043...A recipient at a state-operated mental health facility is not receiving services in the least restrictive environment. The recipient's legal status is unknown. Rambeau moved to accept the new complaint for investigation. The motion was properly seconded (Farmer) and carried.

11-110-9044...A recipient at a state-operated mental health facility has not been provided with adequate care for a medical condition (hypoglycemia). Monitoring of blood sugar levels have not occurred, and the facility policy does not mandate PRN monitoring. Mumford moved to accept the new complaint for investigation. The motion was properly seconded (Farmer) and carried.

11-110-9045...A recipient at a state-operated mental health facility is not receiving adequate treatment for a medical condition. Farmer moved to accept the new complaint for investigation. The motion was properly seconded (Livesay) and carried.

11-110-9046...Recipients at a state-operated mental health facility consistently have items missing from their commissary storage. Livesay moved to accept the new complaint for investigation. The motion was properly seconded (Mumford) and carried.

11-110-9047...The complaint is regarding a state-operated mental health facility. The allegations are as follows: 1) Recipients are placed in full leather restraints when they are not needed, but used as a means to trigger the pursuit of court-ordered medications. 2) Recipients are served food and beverage items that have outdated expiration dates. 3) Recipients are required to wear clothing that is in poor condition. 4) Housekeeping conditions are poor. 5) Air filters are not routinely changed. 6) The facility's internal process for investigating allegations of abuse is inadequate. Rambeau moved to accept the new complaint for investigation. The motion was properly seconded (Farmer) and carried.

Mumford moved to enter closed session to discuss confidential information. The motion was properly seconded (Farmer) and carried. Closed session began at 6:45 PM. The closed session ended at 7:45 PM. Coordinator Atherton summarized the closed session. Case status updates were given for four cases. Four Reports of Findings were approved as written. One Report of Findings was approved, subject to the HRA Director's approval, and one was tabled for acceptance. Two Cases with Reports of Findings were approved for closure, and the Authority voted to make the findings a part of the public record. One case was approved for closure without issuing a Report of Findings due to informal resolution. One pending case was accepted for investigation.
