NOVEMBER 10, 2011 MINUTES

INTRODUCTIONS

In the absence of the Chair and Vice-Chairperson Member Cannady recognized that a quorum was not present and the visitors stated that they would not stay for the meeting unless the HRA needed more information. The Coordinator explained that the HRA would review a report of findings and if the members present and at least one more member approves the report and after administrative approval if would be issued within ten days of the meeting. The Trinity representatives agreed that they would not stay for the meeting.

The Coordinator read the confidentiality statement that indicates that personally identifiable information should not be presented in public meetings in order to protect the privacy of those disabled persons on whose behalf the HRA conducts investigations.

Member Cannady confirmed that some actions from the meeting would require approval of a quorum. Member Cannady asked for changes in the agenda. There were none.

MINUTES

The members reviewed the stated minutes of the September 13, 2011 HRA meeting and considered them for approval. Members agreed to approve the minutes based on a motion by Thomas Cannady, seconded by Carol Neudecker and considering ratification will take place next month.

COMMUNICATIONS: The Coordinator noted that Sandy Burbank resigned her HRA position due to a new work schedule and Beverly Sweatman has agreed to return to the Authority pending approval by the Director.

Members present agreed to continue the current set of officers, Emil Wilson Chairperson, Kingston Schmid, Vice-Chairperson and Marguerite Riley, Secretary.

NEW BUSINESS:

12-070-9008 - a staff called a patient an asshole and other staff witnessed. The consumer asked to call OIG and instead security came to question him. The OIG did not come to question the consumer until the complaint was reported to the HRA, who called OIG and after that, OIG showed up but did not interview the perpetrator. Later staff took away his bracelet in what seemed to be retaliation for reporting the allegation. Upon a motion by Marguerite Riley seconded by Carol Neudecker, members present agreed to investigate.

12-070-9009 - a consumer is super sensitive to pain all over his body the Physician says its all in his head and refuses to offer a ct scan. The consumer stated that just prior to admission, a Physician told him that he needed a ct scan and now the facility will not offer that treatment. Upon a motion by Thomas Cannady, seconded by Margaret Merrell members voted not to investigate the allegation.

12-070-9010 - a consumer has had bronchitis that has not been treated. He stated that several weekends ago, while several female consumers were in his face, the staff refuse to allow him to go to his room to have respite from the unit. Upon a motion by Marguerite Riley, seconded by Thomas Cannady, members present agreed to investigate.

12-070-9011 - the hospital administers benedryl and Zyprexa because she cannot sit still. The consumer claims that she is not a danger to herself or others but staff threatens her with restraint if she does not comply with taking emergency medication. Upon a motion by Thomas Cannady, seconded by Carol Neudecker, members agreed to case opening.

12-070-9012 - a consumer had sex with a staff member and then the hospital reduced his privileges and forced him to take a blood test. Upon a motion by Thomas Cannady, seconded by Carol Neudecker, members agreed to table case opening until receipt of the OIG report.
