New Complaints:

#13-030-9004- Anixter Center. The complaint indicates that a recipient was administered psychotropic medication without the consent of his physician or guardian, that the facility would not send the ward's monthly budget to the guardian after his request, that the ward has not been eating healthy food and his roommate has been eating his food, that the ward's money has not been used to purchase appropriate clothing for the ward, and that the facility has not addressed any of the guardian's concerns about the care of the ward. A release of information has been

obtained. Beth made a motion to accept the complaint for investigation. The motion was properly seconded and carried.

Beth made a motion to go into closed session at 5:40 p.m. pursuant to Section 3955/21 of the Guardianship and Advocacy Act to discuss reports and responses and other matters which could not be discussed without revealing confidential information. The motion was properly seconded and carried.

The HRA returned to open session at 5:48 p.m. having taken no action in closed session. A summary of the closed session includes updates on open cases, discussion of reports as well as responses, and case closures.
