#13-030-9006- Swedish Covenant. The complaint alleges that a recipient was administered forced psychotropic medication in violation of the Mental Health Code, that staff used bodily force against the recipient for no adequate reason, and that staff refused a recipient her own food for her special dietary needs. A release of information has been obtained. David made a motion to accept the complaint for investigation. The motion was properly seconded and carried.

David made a motion to go into closed session at 5:30 p.m. pursuant to Section 3955/21 of the Guardianship and Advocacy Act to discuss reports and responses and other matters which could not be discussed without revealing confidential information. The motion was properly seconded and carried.
