The regular scheduled meeting of the Human Rights Authority, South Suburban Region was called to order by Judith Rauls, Chairperson at 9:05 a.m.

I. CALL TO ORDER

The Chairperson read the confidentiality statement. It was determined that a quorum was present, and all business could be conducted. Introductions were made. The meeting agenda was changed to accommodate our guests.

II. COMMUNICATION

It was moved by Theresa Buell to accept the March 8th, 2012 Meeting Minutes without changes. Motion was seconded by Georgia Jones and carried.

III. UNFINISHED BUSINESS

12-040-9012 (Hospital) Carol Genutis moved to accept the complaint that the hospital routinely does not follow the Mental Health requirements concerning admonishment of rights prior to examination, preparing certificates, seclusion and restraints. A signed Release of Information was not received and masked records will be requested. Motion was seconded by Michele Arthur and carried. Michele Arthur and Judy Rauls were assigned to the case.

12-040-9013 (Correctional Center) Michele Arthur moved to not accept the specific allegation concerning a physician's medical diagnosis and treatment because it is beyond the Authority's scope of authority and competence, per the HRA administration determination. Motion was seconded by Kimberlee Brewerton and carried.

12-040-9014 (Hospital) Carol Genutis moved to accept the complaint that a recipient was detained, administered psychotropic medication and transferred against his will. It was also alleged that the physician was verbally abusive. A signed Release of Information was received. Motion was seconded by Michele Arthur and carried. Georgia Jones and Carol Genutis were assigned to the case.

12-040-9015 (Nursing Home) Michele Arthur moved to postponement accepting the complaint because a signed was not received. Motion was seconded by Kimberlee Brewerton and carried.
