New Complaints

14-060-9002 - School - The complaint states that a student's password is derogatory in nature and staff have not intervened to have the password changed. The staff do not recognize or

address triggers that result in self-stimulation behaviors. The student has been removed from the classroom and placed in a hallway due to the self-stimulating behaviors sometimes for up to 80 minutes. The assigned aide does not have adequate training to address the student's needs and to effectively implement the student's IEP. The school blocks the handicapped parking space. For the student, the parent uses the space, which is closer to the entrance, to protect his safe entrance into the school. A release has not been received. It was decided to send another release.

14-060-9003 - 16 Bed ICFDD - The complaint states the home is chronically understaffed even though Public Health at a recent survey had made recommendations to increase staffing, but this had not happen. The residents at the home had pooled their money to purchase a Wii game. The game has been missing. The agency has not replaced it even though it was believed that a staff person may have taken the game. The complaint is anonymous. The HRA advised the coordinator to call Public Health and to contact the provider about the missing game to see if the provider would replace the game and the complaint could be resolved informally.
