The members consented to accept both allegations for investigation. A signed release of information was received. Georgia Jones and Lauren Pell gave their votes for a majority after the meeting. The case will be ratified at the next meeting.

13-040-9011 (CILA) The Vice Chairperson motioned to accept the allegation concerning the resident having a large knife that compromised the safety of others in the home. The members consented to accept the complaint for investigation. A signed release of information was received. Georgia Jones and Lauren Pell gave their votes for a majority after the meeting. The case will be ratified at the next meeting.
