The regular scheduled meeting of the Human Rights Authority, South Suburban Region was called to order by Judith Rauls, Chairperson at 9:13 a.m.

I. CALL TO ORDER

The Chairperson read the confidentiality statement. It was determined that a quorum was present and that all business could be conducted..

II. COMMUNICATION

It was moved by Maria Heer to accept the May 9th, June 13th, August 8th and September 12th, 2013 Meeting Minutes without any changes. Motion was seconded by Lauren and carried.

14-040-9005 (Nursing Home) The Chairperson motioned to accept the complaint involving the lack of transportation to medical appointments with community medical providers. The complaint also alleged that the resident is not provided with snacks that contain sugar because of alleged diabetes. A signed release of information was received. Lauren Pell moved the motion. Carol Genutis seconded and carried.

14-040-9006 (CILA) The Chairperson motioned to refer the complaint involving verbal and physical threatening behaviors from a staff person to the Office of the Inspector General for follow up. The Chairperson motioned to accept the complaint stating that the resident is not allowed visits or phone calls with her boyfriend. Lauren Pell moved the motions. Carol Genutis seconded and carried.

14-040-9007 (Nursing Home) The Chairperson motioned to accept the complaint stating that the resident was inappropriately discharged from the facility pending a signed release of information. The complaint also stated that the resident's belongings were not returned on the

discharge day and that the staff refuses to send her items to her placement. Lauren Pell moved the motion. Carol Genutis seconded and carried.

The agency's Executive Director has not returned the Coordinator's calls or responded to letters regarding a response to the report. The members consented to vote for enforcement upon returning to open session.

The case was discussed with the provider's representative who told the HRA members that the agency is unable to obtain records from the phone company to support that the resident's guardian was notified. However, the agency still asserts that the guardian was informed about incidents during staffing, meetings and phone calls. The report will be revised for the next meeting.

13-040-9011 (Progressive Careers and Housing (Maria and Georgia) A report was reviewed.

Open session reconvened at 11:06 a.m. having taken no action in closed session. A summary of closed session included case assignments, eight progress reports, two reports and two provider's response.
