The March 2024 HRA Board Meeting Minutes were reviewed. Mary Auth motioned that the minutes be approved. Sandra Dixon seconded, and the motion carried. New Business:

B. New Complaints:

24-060-9017 (Hospital Psychiatric Unit) Complaint Summary: Allegedly, the individual found a pen on the floor and turned it into staff, but staff accused the individual of lying about finding the pen. The complaint alleges the facility is retaliation against the individual after the individual

filed a complaint about staff accusing him of lying. Allegedly, the individual is not allowed a menu to choose his food and is forced to get whatever staff decides to give him. Additionally, the complaint alleges the individual is only getting half full cups of coffee while others are getting full cups. Paulette Brock made a motion to not accept the complaint due to lack of a release. The motion was properly seconded by Janet Manning. Motion carried.

24-060-9019 (Hospital Psychiatric Unit) Complaint Summary: The complaint alleges the facility is allowing visitors onto the behavior health unit to harasses patients. Allegedly, staff are spitting in patient's food. The complaint alleges the individual was given medication he did not consent to. Janet Manning made a motion to not accept the complaint due to lack of a release. The motion was properly seconded by Dan McCarthy. Motion carried.

24-060-9020 (Hospital Psychiatric Unit) Complaint Summary: The complaint alleges the facility took away the individual's clothing and had the individual wear paper clothes. Allegedly, the individual was cold, but staff refused to give the individual a blanket or sweater for 3 days. Allegedly, patients are not allowed access to their rooms for 12 hours a day and must use a community restroom that is not supplied with hand soap. The complaint alleges the facility failed to give the individual a copy of her voluntary admission, patient bill of rights or request for discharge papers. Allegedly, patients are not allowed to use the telephone from 9pm-9am and during group therapy as the telephones are shut off during this time. The complaint alleges the facility does not post advocacy agency information and phone numbers as required. Paulette Brock made a motion to table the complaint and wait for a release. The motion was properly seconded by Mary Auth. Motion carried.

24-060-9021 (Mental Health Facility) Complaint Summary: The complaint alleges the facility refused to discharge the patient even though the patient was suitable for discharge. Allegedly, the patient requested discharge on a Monday and the facility automatically told the patient they would not discharge him for 5 business days. Allegedly, the facility will not discharge patients on weekends. The complaint alleges the facility does not have advocacy agencies information posted. Allegedly, staff refuse to provide contact information for advocacy agencies. Dan McCarthy made a motion to table the complaint and wait for a release. The motion was properly seconded by Paulette Brock. Motion carried.

24-060-9022 (School District) Complaint Summary: The complaint alleges the school district denied the recipient an ADA accommodation request. Furthermore, the complaint alleges the school district's polices discriminate against persons with disabilities. Allegedly, the district polices require individual's to submit ADA accommodation request in advance of any school board meetings. Additionally, the accommodation request needs to include "supporting documentation". Paulette Brock made a motion to accept the complaint. The motion was properly seconded by Dan McCarthy. Motion carried.

24-060-9023 (Mental Health Facility) Complaint Summary: The complaint alleges the individual was verbally attacked and threated by a peer while staff watched. Allegedly, the individual was inappropriate discharged as a result of being attacked by the peer. The complaint alleges the facility failed to keep the individual's personal health information confidential. Allegedly, the individual's medical health papers were left unattended in a vehicle. Mary Auth

made a motion to table the complaint and wait for a release. The motion was properly seconded by Adam Casario. Motion carried.

24-060-9024 (Nursing Home) Complaint Summary: The complaint states the guardian has five individuals that reside at the facility. Allegedly, the facility failed to notify or include the guardian in all of the individual's medication decisions. Allegedly, the facility is making changes to the individual's medication without notifying or obtaining consent from the guardian. Paulette Brock made a motion to accept the complaint. The motion was properly seconded by Dan McCarthy. Motion carried.

24-060-9025 (CILA) Complaint Summary: The complaint states the facility is not following residents preferences when it comes to hair care and styles. Allegedly, the facility is refusing to provide training for staff or hire a professional hair stylist to properly care for residents hair. Dan McCarthy made a motion to table the complaint and attempt to handle informally. The motion was properly seconded by Sandra Dixon. Motion carried.

24-060-9026 (CILA) Complaint Summary: The complaint states the facility is not following residents preferences when it comes to hair care and styles. Allegedly, the facility is refusing to provide training for staff or hire a professional hair stylist to properly care for residents hair. Dan McCarthy made a motion to table the complaint and attempt to handle informally. The motion was properly seconded by Sandra Dixon. Motion carried.

The complaint alleges the new design will close the street from vehicle traffic so there will be no parking for people with disabilities to access business in the downtown area. Paulette Brock made a motion to table the complaint and attempt to handle informally. The motion was properly seconded by Janet Manning. Motion carried.

Mary Auth made a motion to enter executive session at 3:47pm. Pursuant to Section 120/2 (c) (4) and (10) of the Open Meetings Act (5 ILCS 20), Section 3955/10 of the Guardianship and Advocacy Act (20 ILCS 3955) and Section 110/5 of the Mental Health and Developmental Disabilities Confidentiality Act (740 ILCS 110); the motion was seconded by Adam Casario and carried. The purpose of the closed session was to discuss confidential aspects of cases. The HRA returned to open session at 3:56pm having taken no action in closed session. Executive minutes were recorded.
